

RELEASE FORM FOR STUDENTS CLIMBING PARK - DONAUINSEL

Dear parents/legal guardians,

We are delighted that your child is visiting our Climbing Park - Donauinsel.

Our parcours can be used by children (minimum height 110 cm) without being accompanied by their parents or legal guardians. Kids under 8 years have to be accompanied by an adult.

The climbing park is officially deemed suitable and certified with the **ISC SMART SNAP** Safetysystem with the Safetystatus D from EN 15567 (it is not possible to unhook the carabiners completely). It has been found by the authorities to be suitable for sole use by children aged 8 and over.

Please read the following information carefully in order to decide whether you believe your child is capable of using the climbing park and if you give permission:

The Climbing Park - Donauinsel is designed with the **intent to challenge** participants physically, psychologically and mentally. The completion of the courses includes climbing, jumping, balancing, sliding, cycling, flying fox and other activities at natural and artificial obstacles. The station varies in height from 0' to 8' meters above ground.

Participants of the course will travel independently from station to station without a guide and are expected to be completely responsible for themselves. It is important that all participants take full responsibility and understand the risks involved in taking part in the challenges presented at the climbing park.

DISCLAIMER

I am completely aware that the climbing park will place high **physical and psychological demands** on the participant. In addition the participant acknowledges that taking part in the activities of the climbing park, there is a possibility of severe injury. I fully understand the risk involved in the climbing park and my child enters at their **own risk voluntarily**. I assume all dangers or risks (both known and unknown) associated with my kids' participation in the climbing park and release Event4you GmbH as well as their staff from all legal claims arising from my kids' participation. According to my own estimations (on site or from pictures on the internet) regarding the climbing park, I consider my child fully capable of managing the course independently. After the preliminary introductory explanation regarding the use of the course, in accordance with the safety regulations, your child has the option to discontinue the course and receive a full refund.

I confirm that I have completed the registration form truthfully and that my child does not have any health-related problems or handicaps that could impair their activities in the climbing park.

I commit myself to inform the Event4you GmbH management immediately if any circumstances such as injuries or illness arise that could impair the ability of my child to continue with my participation in the climbing park. The use of the climbing park is according to the terms of the General Trading Conditions of Event4you GmbH, which I agree to accept and adhere to.
